FACTS Management Company will continue to manage our tuition billing and payment processing for the 2017 – 2018 School Year. ***Families who are currently enrolled at St. Rose will be reenrolled with the same payment plan. Please contact Mrs. Kim Izzi if you would like to change your payment plan.*** *New families may choose from the three payment plans offered by FACTS Management:*

- Pay in Full – July 2017 (no fee)
- Two Installments – July 2017 and January 2018 (\$20 fee)
- Ten Installments – July 2017 through April 2018 (\$45 fee)

Additionally, you may choose a due date of the 1<sup>st</sup> or the 15<sup>th</sup> of the month. The FACTS enrollment fee (if applicable) is payable directly to FACTS Tuition Management. *You will be billed or charged directly by FACTS Tuition Management within 14 days of your enrollment. ## **St. Rose of Lima Registration and Billing Information**

The St. Rose of Lima School Registration Fee *has been increased to \$175.00* per FAMILY and is payable to St. Rose of Lima School when you register. The registration fee includes a membership in the Eight Month Club which is a fundraiser that benefits Saint Rose of Lima School. Membership includes participation in weekly drawings of \$50.00 and final drawing of the Grand Prizes.

### **Parishioner Rate:**

If you have been a registered member of SS. Rose & Clement Parish for one year, attend Mass weekly and contribute at least \$10 per week, then you qualify for the Parishioner tuition rate. If the minimum is not maintained, a family will be changed to the "Non-Parishioner" rate and billed accordingly. Contributions will be checked on a quarterly basis.

### **Non-Parishioner Rate:**

If you are a member of another parish or of another Faith, then you qualify for the Non-Parishioner rate. If you are a registered and active member of your church, you may be eligible for assistance. Please check with your pastor or religious leader.

### **Financial Aid:**

There is a limited amount of financial aid available for students who attend St. Rose of Lima School. Please consult the enclosed Financial Aid information sheet for more information and deadlines. *Please note: Financial aid is NOT available for Pre-Kindergarten students.*

### **Delinquent Tuition Accounts:**

Students whose tuition accounts are sixty (60) days in arrears will not be allowed to continue classes unless parents meet with the Tuition Office to work out a payment plan. All accounts must be paid to date in order for students to participate in the end-of-year activities.

### **Returned Checks - By using a check for payment, you agree to the following terms:**

In the event your check is dishonored or returned for any reason, you authorize us to electronically (or by paper draft) re-present the check to your bank account for collection of the amount of the check, plus any applicable fees as permitted by law.

### **Tuition Reimbursement:**

The annual school budget is prepared based on projected enrollment for the coming school year. As students register for the new school year, supplies, materials and textbooks are purchased and staff is hired to provide a sound educational program for the enrolled students. Tuition payments begin July 1<sup>st</sup> in order to assure that each classroom is properly staffed and fully supplied for September. Therefore it is the policy of the Saint Rose of Lima School Board not to grant any tuition reimbursement should a child leave our school.

## ***FINANCIAL AID 2017 – 2018***

Tuition assistance is available for children who attend Saint Rose of Lima School. Parents/Legal Guardians are **required to file a FACTS Grant & Aid Application (including a copy of your IRS Federal Tax return) with FACTS Grant & Aid Assessment\*** by **February 17, 2017** for the school year beginning Fall 2017. Applications are processed online at <https://online.factsmgt.com> through your FACTS Tuition account. The link to FACTS can be found on the St. Rose School website at [www.saintroseschool.com](http://www.saintroseschool.com). **No financial aid is granted without the proper filing of all necessary forms and documents.**

*\*Note: FACTS Grant & Aid Assessment is a service of FACTS Management Company. The Financial Aid Application is in addition to your FACTS Tuition Enrollment Form.*

There are two financial aid options:

- 1) **The Diocese of Providence** sponsors a tuition assistance program for children of modest means. All Diocesan aid is given on the basis of demonstrated need and made possible through contributions given throughout the Diocese to the Catholic Charity Appeal. The Diocese determines who is eligible for assistance by reviewing the information gathered through the FACTS Grant & Aid Assessment process. Awards are given on a graduated scale based on need. ***Please note: The FACTS Grant & Aid application must be submitted online by February 12, 2017 to be considered for an award.***
  
- 2) **Father Ferry Fund** is a program offered through SS. Rose & Clement Parish. This fund was established in 1994 in memory of Fr. John F. Ferry, a priest and scholar who served many years at St. Rose of Lima Church. Donations to this fund provide financial assistance to active parishioners (those who attend Mass every week) who attend Saint Rose of Lima School. ***You must complete the FACTS Grant & Aid application in order to be considered for tuition assistance from the Fr. Ferry Fund. Please note: The Fr. Ferry Fund application must be submitted to the Tuition Office by February 17, 2017 to be considered for an award.***

## **Saint Rose of Lima School Spiritual and Financial Commitment**

**Spiritual Commitment:** Every school has academic instruction as its fundamental purpose. All elementary schools teach essentially the same subject matter. **Financial Commitment:** In addition to the parish subsidy to the school, it is the responsibility of each family to pay tuition in a timely fashion. *If there is any problem with payment of tuition, parents must notify the tuition office immediately. Failure to meet this obligation or contact the tuition office will lead to the dismissal of the child from the school.*

**Parishioners:** Saint Rose of Lima School is a parish school. SS. Rose & Clement Parish subsidizes a substantial portion of the operating budget of the school. As a practicing Catholic family, you promise to donate a minimum of \$520 per year (\$10 per week) to support the parish.
